- Jason Lauritsen For goals Change first goal of old plan and replace with an ecological goal or have it as an objective under goal 2 in the old plan. Will give more thought on combining 2 & 3 (on 1st page). Need to change out "delineate regional trail systems"
- Sarrah Glassner Promote the FGTS is the most comprehensive goal
- Shawn Thomas Promotion goal add education component to it. This is important given the influx of new people to FL and outdoor recreation in general. We should be highlighting objectives and tasks that have been completed
- Mike Stephens Should combine goals 2 & 3 (on 1st page) and goal 3 (on page 2) into one goal. Need to include language regarding return on investment in the economic goal.
- Parks Small As the work continues, the objectives should change. If sharing documents regarding the plan, we need to consider the Sunshine Law.
- Scott Stryker Work goals 1 and 4 (on page 1) and goal 3 (on page 2) into one goal.
- Stephanie Wardein Need to compile the objectives that have been completed and then focus on what still needs to be done.
- Robin Birdsong Some of these suggestions for new goals might be objectives within the existing goals. Where is the FEGN at? What is that status and should we add it in?
